UNDER THE MASSACHUSETTS WETLANDS PROTECTION ACT  
AND THE HOPKINTON WETLANDS PROTECTION BYLAW

In accordance with the Massachusetts General Laws Chapter 131, Section 40, and the Hopkinton Wetlands Protection Bylaw, § 206-6.A., you are hereby notified of the following.
