## **COVID-19 Updates & Precautions**

### **March 24, 2020 PM update**

The Massachusetts Department of Public Health has confirmed that COVID-19 is spreading throughout the Commonwealth. There are presently six positive cases in Hopkinton; as testing increases, more cases may be identified in our Town.

**Governor Charlie Baker issued an [emergency order](#) requiring all businesses and organizations that do not provide “COVID-19 Essential Services” to close their physical workplaces and facilities to workers, customers and the public as of Tuesday, March 24th at noon until Tuesday, April 7th at noon. These businesses are encouraged to continue operations remotely. To that end, essential services provided by the Department of Public Works, Facilities, Health Services, Youth and Family Services, Hopkinton Police Department and Hopkinton Fire Department will continue. The rest of the Town Departments will continue to provide services as in prior weeks, albeit employees will be working remotely.**

Town Officials and Emergency Management personnel continue to monitor the rapidly evolving COVID-19 public health emergency. As of 12:00 p.m. on 3/24/20, Hopkinton’s Health Department has 6 confirmed COVID-19 cases. We now have cases within the community that cannot be linked to either travel or known contact with a COVID-19 case. We intend to implement further action necessary to slow the spread of COVID-19 in the community. We will require that all businesses that are deemed essential, comply with social distancing recommendations. Additionally, we will now require and enforce social distancing guidelines if necessary. The Health Department will begin compliance inspections this week. Families and individuals are being asked to stay home, only have contact with immediate family members and to limit unnecessary trips to stores that will remain open. You should only participate in activities in which the recommended space of 6ft between parties is possible. Our mitigation strategy continues to focus on protecting the most vulnerable population and to preserve our public safety personnel and health care workforce.

**All town buildings are closed to the public.**

**Parks, Playgrounds and Playing Fields ARE CLOSED.**

**Department of Public Works - NEW UPDATE**

The Department of Public Works will not issue any permits for excavation within a public way, pending further notice. Permits may be issued for emergency repairs to existing infrastructure only.

**Public Safety:**

Pursuant to Governor Baker's order, Hopkinton Fire Department will be suspending all residential and commercial inspections, until further notice. Please visit the attached link for more information.

**Hopkinton Public Schools:**

Or, if you have another trusted adult in the School System, you may also ask that person to connect you to our Food Services Director. The Hopkinton Food Service Department will also be working closely with Project Just Because.

All fields located on Hopkinton Public Schools grounds are closed.

### **Senior Shopping Hours - local stores:**

**Market Basket:** Stores open only to those 60 and over from 5:30 a.m. to 7 a.m. on Tuesday, Wednesday and Thursday.

**Roche Bros.:** ALL locations will dedicate first hour of business, 7 a.m. to 8 a.m., to customers 60+ as well as the disabled population.

**Shaw's/Star Market:** Stores will open early Tuesdays and Thursdays, 7 a.m. to 9 a.m., for senior citizens and other at-risk members of the community.

**Price Chopper:** Stores only open to seniors from 6 a.m. to 7 a.m.

**Stop & Shop:** All locations open 6 a.m. to 7:30 a.m. daily for customers age 60 and older only.

**Target:** Reducing store hours and closing stores by 9 p.m. daily. First hour of shopping each Wednesday is reserved for "elderly and those with underlying health concerns."

### **Library:**

In accordance with Governor Baker's emergency order on March 23, the library has stopped offering any services that require or encourage residents to leave their homes. **Our book drop is now closed. Please DO NOT return any library materials at this time!** We cannot be responsible for items left outside of the library, which may be damaged by weather or stolen. Item due dates will be extended until the library reopens, and we will forgive fines that may have accrued due to the pandemic.
