5. Cross off any resident no longer residing at this address and list his/her new address.
6. NATIONALITY – enter only if a NOT U.S. citizen.
7. OCCUPATION – Enter occupations, NOT place of employment.
8. To return this form, tri-fold form and insert into return envelope provided and mail.
